

## Minutes of Meeting for Empanelment of Skill Training Providers (2<sup>nd</sup> Phase) under NULM, Bihar

A Technical Evaluation Committee Meeting was held on 29<sup>th</sup> December 2015 from 4.00 PM to 5.30 PM under the Chairmanship of Mr. N. K. Singh, Joint Secretary, UD & HD, Govt. of Bihar to review and finalise the selection list of STPs under EST & P component of NULM project (2<sup>nd</sup> Phase).

The agenda and decisions taken in the meeting are as follows:

Agenda		Discussion Taken
1.	Scrutiny of the draft list	<p>Committee members reviewed the draft list prepared on the basis of criterion for empanelment of new STPs as per EOI.</p> <p>Out of 100 packets received which contained 98 proposals, 39 proposals were found to be eligible as per the criteria.</p>
2.	Grievance Redressal	<p>In order to maintain highest level of transparency, committee decided to post the results of the technical screening of the proposals, which also contained reasons for non-eligibility, on SULM website for 15 days from the date of uploading the same.</p> <p>Committee directed PMC-NULM to collect grievances, if raised, and address them through proper explanation.</p>
3.	Document Fee	<p>As per the Expression of Interest, the applying agencies were requested to enclose a demand draft of the amount of Rs. 5000/- (non-refundable) as document fee. Accordingly, except one, all the agencies enclosed the demand draft of the same amount. However, due to delay in opening of the proposals, the validity of the Drafts expired.</p> <p>Therefore, the Committee decided that eligible agencies should be asked to submit a fresh</p>

	demand draft of Rs. 5000/ (Rupees five thousand only) within 15 days after receiving the communication from BUDA in this regard. In case any agency fails to submit the draft, it will be liable to be rejected for further evaluation and selection process.
