
A meeting of the Technical and Financial Evaluation Committee was held under the Chairmanship of Sri Narendra Kumar Singh, IAS, Additional Secretary-cum-Director for Technical Evaluation of the bids opened on 30.12.2016 for **“Selection of agency/firm for the printing of approximate 60000 Plastic Identity Card as per specification given by the department for Surveyed Street Vendors of the different Municipal Corporation/Municipal Council/ Municipal Panchayat of Bihar State”**. The proceedings of the meeting are as follows:-


- (i) On the basis of NIT terms & conditions and prequalification criteria the detailed Technical Evaluation of 8 bids have been undertaken by the committee. A detailed evaluation sheet is annexed at **Annexure-A**.
- (ii) As per the Technical Evaluation Sheet, Out of 8, the 5 agencies i.e. (1) **Print Mart India Pvt. Ltd, Patna**, (2) **Diagraph Implex Pvt. Ltd., , Kolkata**, (3) **ARS Group, Patna**, (4) **Shiva Enterprises, Patna** (5) **Surya Enterprises, Patna** have not technically qualified for the reasons mentioned in the remarks column of **Annexure-A** at sl. No.1, 3, 4, 5, and 6. Based on the detailed discussions and review of Technical and Financial Evaluation Committee, it has been recommended that, the technical bids submitted by the above 5 agencies are unacceptable and will not be considered for the opening of their financial bid.
- (iii) As per Technical Evaluation Sheet, the 3 agencies i.e. (1) **DATATEK Software Pvt. Ltd., Patna**, (2) **Mahabaudh Jan Swasthya Evam Sarvangin Kendra, Patna** and (3) **Savant Tech Sol Pvt. Ltd., Patna** have been technically qualified. The committee has recommended that, the technical bids submitted by the above 3 agencies were acceptable therefore their financial bid could be opened.
