

Minutes of Meeting - State Urban Livelihoods Mission-Bihar

A meeting was held on November 09, 2015 at 11.00 AM to review the progress & achievements of Social Mobilization & Institution Development (SM&ID) and Support to Urban Street Vendors (SUSV) under NULM, Bihar. The meeting was chaired by the Director cum Joint Secretary, UD &HD. The list of the participants is enclosed in separate sheet. The issues and decisions taken in the meeting are as follows:

1.	Formation of SHGs	 3000 SHGs will be formed by APMAS in 17 towns and 6000 SHGs will be formed by SPUR in 28 Towns during the financial year of 2014-15, 2015-16 and 2016-17. In the month of October'2015, 1467 new SHGs have been formed, the saving account of 671 SHGs have been opened and revolving fund of 38 SHGs have been received through the assistance of APMAS in 17 towns. It is realized that the performance of APMAS should be improved under the component of Social Mobilization & Institution Development. APMAS will nurture all 9000 SHGs in 45 Towns through the assistance of revolving fund, opening of basic saving account, credit linkages and other social security program. 			
2	Formation of ALFs	 Area Level Federations will not be formed by APMAS. But APMAS will assist the CMMU staffs to form the Area Level Federations. 			
3	Verification of ULBs	 The monthly progress report should be verified by Municipal Commissioner/ Executive Officer of respective ULBs; otherwise the verification report will not be accredited for the disbursement of fund to Resource Agencies. 			
4	Upload the data of SHGs members in MIS	 APMAS will submit the member wise data of SHGs formed under 17 Towns and SPUR will submit the member wise data of 28 towns by 30th November'2015 for uploading in MIS.APMAS and SPUR will upload the data separately. 			
5.	Eviction of street vendors	 The eviction of street vendors in every town creates the obstacle for continuing the bio-metric survey. Therefore, administration should support to do the survey of street vendors. 			
6.	Upload the data of street vendors in MIS	 The data of 31,073 street vendors has been uploaded in MIS. The data of street vendors should be uploaded by NASVI 			
7.	Issue of I-Card & vending certificate to street vendors	 The format of I-card and vending certificate has been submitted to UD&HD for approval. After 15th November'2015, the I-card and Vending certificates have to be issued to street vendors through digitalized mode.
