The 4th meeting of the **State Level SUH Monitoring Committee** was held under the Chairmanship of Shri Girish Shankar, *IAS (Retd.)*, to review the progress of Shelter for Urban Homeless (SUH) under DAY-NULM.

1.	Confirmation of Minutes of the 3 rd Meeting held on 14 th September 2018.	Proceedings of the last meeting held on 14 th September 2018 were confirmed.
2.	Preparation of Plan of Action for Urban Homeless as per direction of the Hon'ble Supreme Court.	<p>PMC-NULM presented the draft Plan of Action (PoA) prepared for Urban Homeless as per Hon'ble Supreme Court order passed on 7th September 2018 in the case of Writ Petition (C) No. 55/2003 (E.R. Kumar & ANR Vs Union of India & ORS). Detailed discussion was held on draft PoA and the committee suggested following points to be incorporated in the draft of PoA:</p> <ul style="list-style-type: none"> • A detailed analysis of surveyed homeless and classification of homeless as per surveyed data. • On the basis of analysis of data, the number and category of shelters required to be established in each city. • Present status of Shelters sanctioned and operational in the state. • Plan of Action to cater all surveyed homeless under the Shelter for Urban Homeless (SUH) Scheme. • Role of other government departments in terms of linkage & convergence and to cater to special category of homeless in their shelters. • Services to be provided to the homeless in the shelters. • Funding support for O&M and other services of shelters. • Timeline for completion of action as well as for each activity to be decided under PoA. <p>PMC-NULM was directed to prepare a revised draft Plan of Action incorporating above directions and suggestions. It was decided by the committee to share draft of PoA with all members of the Committee and with other concerned department's representatives for their suggestions and comments.</p>

	and Surveyed Homeless data.	the Census 2011 and Homeless surveyed by the ULBs. Decision was taken for re-verification of surveyed homeless data in cases where major differences have been found between Census 2011 and Surveyed Homeless data.
4.	Next meeting for finalization of Plan of Action.	The Committee requested all members present and representatives of other government department to give their suggestions and comments on draft of PoA at the earliest. It was also decided that another meeting be fixed on October 31 st 2018 at 9.30 AM for discussion and finalization of the draft Plan of Action to be submitted to Hon'ble Supreme Court.
